

## ADMISSION REQUIREMENTS

*The IFNU is an equal opportunity institution, and international students are admitted regardless of race, sex, native language or religion.*

### **Main documents to be presented to IFNU by the candidates are:**

- Personal application form
- Notarized copy of the Certificate of education with grades obtained
- Certificate of health with the results of AIDS-test as well as the permission to study in Ukraine
- Copy of Birth Certificate and four photographs of 4x6 size
- Medical Insurance Policy
- Copy of applicant's passport
- Roundtrip airplane ticket with open date of return or a copy of an e-ticket form

### **Additionally, the IFNU requires submission of the following documents:**

- Copy of applicant's passport
- Official evidence of financial resources necessary to cover both tuition fee for the whole term of study and related costs, issued by a bank in the student home country or by an applicant's sponsor.

The admission procedure is completed by signing the agreement between the applicant (or his/her agent) and the IFNU.

## HOW TO ENROLL

### **If you would like to enroll, please follow these simple steps:**

- 1) Select your course/s.
- 2) Complete the application form. All sections of the form must be completed and the declaration signed and dated.

### **Application Forms can be submitted either by the following:**

**NOTE:**

- 3) Upon confirmation of your application with a **positive reply** from PSIS, send your supporting documents to the IFNU of Lviv at the PSIS address.

**NOTE:**

***It is preferable to use courier mail to save time.***

***Also, please contact Ukrainian Embassy/Consulate for your country and find out their requirements for student visa applicants.***

- 4) Applicants will receive a Letter of Offer stating the course that he/she has been accepted into and including fees to be paid as well as a copy of Agreement for study.
- 5) Sign the Agreement form. Return the Form to the IFNU or to your agent.
- 6) Upon receipt of these documents, we will issue and mail out an Official Invitation to enter Ukraine. Students must present this Invitation to the Ukrainian Embassy/Consulate for their home country to obtain a Student Visa.
- 7) Upon the receipt of the Agreement signed, we will issue a confirmation to Ukrainian Ministry of Education to enable you to enter Ukraine.

**NOTE:**

***All international students will enter Ukraine within the period of time from 15 August to 15 November.***

- ***We advise you to submit application forms as early as possible.***
- ***It is recommended to arrange the arrival at the IFNU as early as possible.***
